## Implementation of the Federation – Territorial Assessment August 2023

In preparation for the 2024 Regnum Christi General Convention, each territory was invited to reflect on what stage they are at in terms of implementing the Federation. Territories were provided with a rubric to guide them in their reflection. The document shows the results of our assessment from the perspective of the Territorial Directive College.
